#### **Joint Strategic Needs Assessment (JSNA)**

The HWB is responsible for producing and refreshing the South Gloucestershire JSNA.

This is a systematic method for reviewing the health and wellbeing needs of a population, leading to agreed commissioning priorities that will improve the health and wellbeing outcomes and reduce inequalities.

The HWB reconvened a JSNA Steering Group to review the existing content and align to new opportunities and new ways of working.

This work culminated in June 2022 with a new interactive population health intelligence portal for South Gloucestershire – home to the JSNA

# Joint Health & Wellbeing Strategy 2021-25 (JHWS)

Following public consultation, in October 2021 the HWB approved the JHWS.

The JHWS provides the future strategic vision for health and wellbeing in South Gloucestershire, setting out key strategic priorities for action and clear outcomes as identified in the South Gloucestershire Joint Strategic Needs Assessment (JSNA).

## Joint Health & Wellbeing Strategy Action Plan deep dive

The HWB commenced a programme of deep dives into JHWS strategic objectives.

The overarching theme to reduce inequalities was the focus of the first deep dive in March 2021.

#### Discussion included:

- Reducing inequalities is 'everyone's business'
- Collective actions are about showcasing examples of best practice within the HWB and referencing existing related strategies
- Disproportionate outcomes need to be addressed, e.g. over representation of dual heritage persons within the criminal justice system
- Information provided to the Equalities in Education Group to support individuals to improve outcomes could be shared with the HWB
- Climate emergency actions to be joined up across partners, particularly the health system, and contribute to more environmental choices around purchasing







#### **Collaboration with South Gloucestershire Locality Partnership**

Development sessions on the evolving health and care system population health outcomes framework and the South Gloucestershire JSNA; and the relationship with the South Gloucestershire Locality Partnership.

#### Reflections included:

- Strong history of collaborative working in South Gloucestershire that we can build on.
- The HWB and LP aims have a lot of synergy which must be harnessed to benefit our joint population.
- Important to learn from Covid-19 collaborative working and the agility in response across providers coming together.

#### Outcome:

Joint working group to further develop a shared vision and initial areas of priority (what we can do better together), agreed in June 2022 as:

- Ageing Well
- Adult Community Mental Health
- Children and Young People Mental Health
- Prevention
