Local leadership in the new Bristol, North Somerset and South Gloucestershire (BNSSG) Integrated Care System

The HWB has provided a critical forum for political, clinical, professional and community leaders from across the health and care system to come together in South Gloucestershire to shape and develop plans to improve the health and wellbeing of our local population and reduce health inequalities.

The HWB and Locality Partnership held four joint development sessions in 2022-23 to build relationships, develop joint priorities and learn about the new health and care landscape (Integrated Care System (ICS), Integrated Care Board (ICB), ICS Strategy and Joint Forward Plan development).

This is a systematic method for reviewing the health and wellbeing needs of a population, leading to agreed commissioning priorities that will improve the health and wellbeing outcomes and reduce inequalities.

In October 2022, the HWB approved the post consultation PNA for publication.

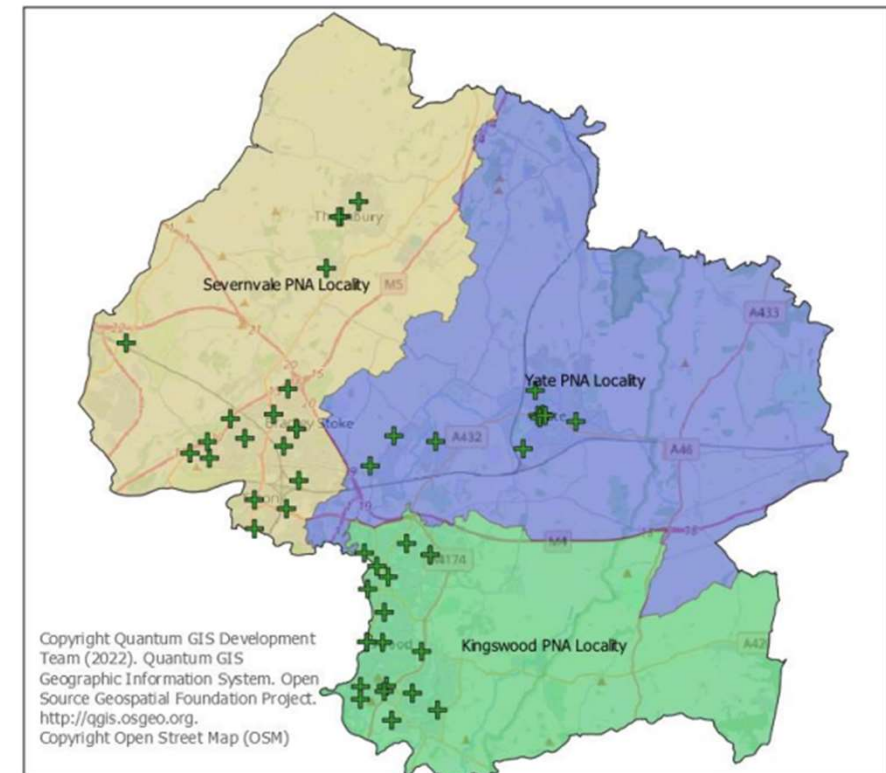
The Board recognised:
